



## TRANSIENT RENTAL RESTRICTION EXEMPTION CLAIM FORM

In support of the State of California Regional Stay-at-Home Order, the Town of Mammoth Lakes is restricting short-term lodging reservations to essential travelers as specified in the updated January 7, 2021 Mono County Lodging Order. The restrictions are in place until the Southern Region is no longer subject to the Regional Order, or Mono County is otherwise released from the coverage of that Order.

The Regional Stay-At-Home Order (RSAHO) will be lifted when regional available adult ICU bed capacity is greater than or equal to 15% and is projected to remain above that level for the subsequent four weeks. At the end of the Stay-At-Home period, each county within the Region will be assigned to a tier based on the Blueprint for a Safer Economy, Check CDPH Website for updated information on RSAHO <https://www.cdph.ca.gov/Programs/OPA/Pages/News-Releases-2021.aspx>.

In addition to allowing rentals to only essential travelers, the Town is requiring all rental operators to reduce rental capacity, including essential travelers, to no more than 30% of capacity at any time for Hotels, Motels, Condo-Hotels and Management Companies operating 10 or more privately owned properties, and no more than 10 rental days per unit per month for operators with less than 10 privately owned properties. This additional restriction is intended to reduce occupancy of essential travelers at one time in a rental facility. All operators must also maintain 48 hours vacancy between occupancy, by either paid rental or owners. Violations of these restrictions will result in fines to the rental operator.
